The following points were changed in the presented report:

- Blank manifestos won't be accepted. (Blank manifesto, here, is defined as a document not consisting vision, mission, proposal or any other views of the candidate)
- A separate window for manifesto submission and ratification for candidates filing re-nomination was added.
- It was also decided that the Chairperson, Students' Senate would send a notification to the student community regarding the elections given the time crunch between the nomination filing and manifesto submission.
- Some changes were made regarding the post for which elections would be called.

The Chief Election Officer also clarified that the Incumbent Executives need not prepare any interim report for these Mid-Term Elections.
