Item No. 2	Announcements and Remarks, if any
------------	-----------------------------------

- 1. The Fencing Workshop organized by the Games and Sports Council was very well received and around 60-70 students attended the workshop.
- 2. The Chairman, SS said that Akshay Aggarwal (12068), Secretary, Students' Senate has resigned.
- **3.** On 8<sup>th</sup> September 2013, International Suicide Day is being observed in the institute and the Head, CS sought permission from Gymkhana to conduct a lecture since it is falling during the by-election week. Permission was granted.
- **4.** As had already been discussed in CoSHA, the SBRA students will be pooled with Hall 3 and Hall 7, and foreign students will be pooled with Hall 10.
- 5. The President asked regarding the specialists required in the campus- a Dentist and Opthalmologist were mentioned. It was pointed out that Ms. Neelam Saxena (Opthalmologist) should be contacted.
- 6. The General Secretary, Games and Sports Council requested to increase the timing of sports facilities from 9p.m to 11p.m and the same was recommended by the house of the senate. This request shall be taken to SPEC through a letter written by the Chairman, Students' Senate to the SPEC chairman.

7. Four office bearers of Students' Gymkhana have been called for participation in IIT gymkhana summit for which the senate asked the executives and chairman to decide among them and let the senate know through senate list.

Item No. 3	To report on action taken.

The Action Taken Report was presented by the Chairman, Students' Senate, for consideration of the Senate. In the course of the discussion of the report, the following items were noted:

#### In ATR No.3, Age Limit for Ph.D Senators:

The Committee presented the report based on the statistics of PhD students age and also said that the Indian Institute of Technology does not come under the University Grant Commission Act and are not legally bound to follow the Age Limit rule of the Lyngdoh Committee. The senate agreed to remove the age bar for all the registered students of IIT Kanpur to contest in gymkhana elections and the same would be communicated to concerned authorities.

In **ATR No. 9,** guidelines for various procedures related to Gymkhana Activities: The Chair of the committee asked to dissolve the committee since the procedural system has evolved in the due course of time. The Students' Senate dissolved the Committee.

**In ATR No. 10,** the President has forwarded the letter to DD for waiving the charges incurred during the festivals for booking VH and other institute facilities.

**In ATR No. 17,** proposal for POS machines for cashless transactions:

The President requested to COSHA convener to take up the issue with the Hall HECs for their consent. In OAT a telephone line is to be provided for Cashless Transaction.

In **ATR No. 19**, the committee has submitted a report about OARS where the short term and long term requirements have been elaborated. The senate accepted the report and the same would be forwarded to Director of the institute.

In **ATR No. 21,** the idea of having single design team was dropped after receiving inputs from the festival team. The major reasons were that the team would be heavily loaded throughout the year and practically it would be difficult for a single team to coordinate with all the festival teams.

In **ATR No. 22,** EVM fact finding Committee: The report of the committee is accepted by the Students' Senate. The committee is not dissolved and will look into this matter further if any issue arises regarding EVM's in future.

Item No. 5	To consider Noting of Constitutional amendments of UGSAC &	
	PGSAC	

The text of the Constitutional Amendment was presented before the Students' Senate for their opinion by the Parliamentarian. The Constitutional Amendment was passed by the Students' Senate and henceforth:

In Chapter 4, Article 4.02 of the Constitution of the Students' Gymkhana, the following subclauses shall be added:

- 3. The Undergraduate Students' Academic Council (UGSAC)
- 4. The Postgraduate Students' Academic Council (PGSAC)
- 4.10 Undergraduate Students' Academic Council (UGSAC)
  - a. The UGSAC shall discuss academic affairs which pertain to undergraduate students. The members of the UGSAC shall represent the students to various Institute academic committees such as SUGC, DUGC etc.
  - b. It shall consist of the In-charge, UG Academic Affairs, the Chairperson, the President, the student representatives to the DUGC of each department, the Students' Senate nominees to the SUGC and SEPC and 2 UG Senators as Senate nominees.





- c. The In-charge, UG Academic Affairs, elected by the Senate, shall be the Convener of the UGSAC.
- d. The Chairperson, Students' Senate shall be the Chair of the UGSAC except if the Chairperson is a postgraduate student and the President is an undergraduate student. In this case, the President shall be the Chair of the UGSAC.
- e. The President or the Chairperson may requisition a joint session of the UGSAC and the PGSAC if an item relevant to both comes up for discussion. Such a session shall be chaired by the Chairperson.
- 4.11 Postgraduate Students' Academic Council (PGSAC)
  - **a.** The PGSAC shall discuss academic affairs which pertain to postgraduate students. The members of the PGSAC shall represent the students to various Institute academic committees such as SPGC, DPGC etc.
  - **b.** It shall consist of the In-charge, PG Academic Affairs, the Chairperson, the President, the student representatives to the DPGC of each department, the Students' Senate nominees to the SPGC and SEPC and 2 PG Senators as Senate nominees.
  - **c.** The In-charge, PG Academic Affairs, elected by the Senate, shall be the Convener of the PGSAC.
  - **d.** The Chairperson, Students' Senate shall be the Chair of the PGSAC except if the Chairperson is an undergraduate student and the President is a postgraduate student. In this case, the President shall be the Chair of the PGSAC.
  - **e.** The President or the Chairperson may requisition a joint session of the UGSAC and the PGSAC if an item relevant to both comes up for discussion. Such a session shall be chaired by the Chairperson

The Students' Senate has requested the CEO to re-submit the Pre-Conduction Report, since the report did not contain relevant rules and regulations, GRC documents. A special meeting was scheduled to be held on 28<sup>th</sup> August to ratify the same.

Item No. 18	To Consider the Post conduction report of Freshers' Nite	
	To be presented by General Secretary, Cultural Council	

The Post Conduction Report of Freshers' Nite was accepted by the Students' Senate with the following modifications/ recommendations:

- 1. There should be a presentation of the Pre-Conduction report of Freshers' Nite.
- 2. Any performance specifically organized by any hall would not be allowed because Freshers' night is a joint effort of the complete Freshers' batch and the Cultural Council. If such an event is desired to be organized, its authenticity should be judged by the General Secretary, Cultural Council. A proper procedure should be followed. Auditions should be taken as done by other clubs and practices should take place in NEW SAC with students of every hall participating in it.

The following were suggestions made to the incoming General Secretary:

1. Generally sound system is put up by Vishal. But this time a new vendor was contacted He proved to be good enough. The sound quality of his system was very bad. It was recommended that Music Club coordinators should be contacted first for choosing a vendor for sound system.





- 2. The timings of all the performances should be added during the rehearsal and the showcase should finish around 10.30 pm so that people can go and enjoy the DJ. If the time exceeds any irrelevant performance should be cut off.
- 3. Start Freshers' Nite by 8:00 pm even if the OAT is not full.
- 4. Promo videos of Festivals or any kind of publicity of any festival should not be done because first it consumes extra time, second there is fight for the order of video screening, it creates lots of controversies and lastly Freshers nite is not a platform for the publicity of these events.

Senate's decision – It should be under the Discretion of the then General Secretary.
